Neighbor by Neighbor is a nonprofit 501c3 organization that works to address food insecurities, homelessness, and the dire needs of the vulnerable seniors in our community. We are a resource for our low-income neighbors in SW Berrien County that provides the tools and education for them to progress from dependence to independence. Neighbor by Neighbor is a much-needed resource, as our clients are struggling right now with food and housing insecurity. Food assistance has been cut by as much as 75% for some of our clients and rent across the state has increased on average by 11%. Clients are calling with electricity and utility shut off notices almost daily.
